5. The Director reserve full right to accept or reject any or all quotations without assigning any reasons thereof.
6. The highest Bidder will be offered and will have to deposit the sale proceed in full in the form of Bank Draft addressed to the Director of the Institute and handed over to the undersigned for issuing necessary order for lifting of the unserviceable items.
7. The tender will be opened on **15/03/2018 at 02:30 pm**.
8. The security money as deposited will be forfeited if the said materials are not lifted within the specific time. The Institute will not be responsible for any loss or damage items if not lifted immediately after finalization of the bid as it where is basis.
9. For the auction of the unserviceable items (Division wise will be sold on "As is where is basis & shall have to be lifted/removed within 3 (three) working days otherwise penalty of Rs.500/- per day shall be charged.
10. The tenderer/bidder is requested to physically inspect all the actionable items in division wise and quote their rates accordingly. In case of any shortfall of the items in the time of lifting. An amount shall not be re-funded back under any circumstances.
