

Guidelines for Submission of Manuscript (Research paper / Conference Abstract / Proceedings Paper/ Book/Book Chapter/Bulletin etc)

1. Any publication of any kind wherein the name of the staff member of the institute appears in the publication as author or co-author, has to be submitted, in the prescribed proforma, through the proper channel forwarded by the concerned Joint Director (JD)/Head of Division (HOD) and processed by the PME Cell. The manuscripts will be submitted for publication to journals /conferences only after final approval of the Director.
2. In order to save the time in screening/approval process, soft copy of manuscript and duly filled and signed scan copy of Form **PMEPub-A** can be sent by email to PME Cell (pmepub.icarneh@gmail.com).
3. The corresponding author shall inform the JD/HOD and the PME of rejection or acceptance and shall submit a copy of the reprint (soft copy and hard copy) for office record.
4. Any paper that is published by institute staff from the institute without the above mentioned procedure will not be treated as part of institutional publications.
5. If any researcher of the institute is associated as a co-author with the publications published/communicated from other institutes, he shall only intimate it to the PME cell. These publications will not be considered as part of institutes' publication unless a substantial part of research is conducted in the institute i.e. ICAR Research Complex for NEH Region. Approval from the PME Cell in such cases is not necessary. This is also applicable to the M.Sc. and Ph. D. works conducted by the researchers during their Masters and Doctoral programmes at their respective universities.
6. Any case of plagiarism, if proven, will result in retraction of the paper from the journal.
7. Conference abstracts/full proceedings papers should be forwarded within 3 days by JD/HOD along with Form PMEPub-A. This should preferably be done through email.
8. PME Research publication screening Committee will process the paper and shall send the recommendations to competent authority within 7 working days for approval.
