





- 1. The crucial date for determining the age limit shall be the closing date of the receipt of the application i.e. 30-12-2014.
- 2. Candidate will have to pay application fee of Rs. 200/- (Rupees Two Hundred) only for General/OBC category and Rs. 100/- (Rupees One hundred) only for SC/ST/PWD category in the form of Demand Draft drawn in favour of The Joint Director, ICAR AP Centre, Basar-791101 payable at SBI- Basar Branch. The application fee paid by way of Indian Postal Orders/Money Orders etc. will not be accepted.
- 3. If the number of applications received in response to advertisement in large, the institute shall have reserves the right to shortlist the candidates for test/interview on the basis of qualification, experience etc and the final the selection is on the basis of written examination and skill test with personal interview.
- 4. The final selection of the candidates will be based on initial screening of the applications, followed by a Written Test/Stenography Test/Interview.
- 5. Age relation: Upper age relaxation of 5 years for SC/ST, 3 years for OBC and 10 years for PH candidates. (The maximum age limit for ICAR employees will be relaxable up to 45 years for the post of Stenographer Grade III.)
- 6. The prescribed qualifications are minimum and an enhanced qualification does not entitle the candidate to be called for test/interview.
- 7. The post is non-government under ICAR, which will be governed by New Pension Scheme introduced by Govt. of India w.e.f. 01.01.2004 mutatis mutandis and as amended, clarified or modified from time to time.
- 8. Candidates already in Govt. service (Central/State/Autonomous bodies) should forward their application through proper channel and NOC has to be produced at the time of interview if called for appearing the interview board.
- 9. A self addressed stamped (worth Rs.6/-) envelope size 23 cm x 10 cm should be sent along with the application form.
- 10. Incomplete applications or applications without latest Photograph, Application fee, Signature and self attested copies of certificates, received after the last date are liable to be rejected and the department will not be responsible for late or non-receipt of applications.
