1. Number of vacancies 1(one) one for the GKMS/IMD Centre at ICAR AP Centre, Basar.
2. The post is purely on contractual basis and co-terminus with the project which is sponsored by the Indian Meteorological Department. The candidate will have no right to claim for regularization of service in no way he/she shall be treated as an employee of ICAR .
3. Depending on turn out of candidate for the Walk In Interview, written test may be held and only those who secure the minimum marks fixed by the Institute shall be interviewed.
4. Place of posting shall be at the discretion of Institute authority and selected candidate will be liable to work in any centre of the IMD within North Eastern Hill Region.
5. Emoluments payable is consolidated (Rs. 15,000/- plus HRA) as per norm fixed by IMD
6. Maximum age limit is 30 years with relaxation for SC,ST,OBC as per rule.
7. No TA/DA and official accommodation will be provided for appearing in the interview.
