Before quoting the tender , it is requested to kindly go through the Tender Document thoroughly and abide by all the Terms and conditions given. Non-compliance of any of the T & C mentioned below, shall lead to non-consideration of the bid and no request what so ever shall be considered under any circumstances.

The detailed Terms and Conditions are as under:

1. The cost of the Tender paper is Rs. 1000.00(Rupees one thousand) only for each work, (Non-refundable) to be deposited in the favour of the Joint Director, ICAR, Mizoram Centre, Kolasib by means of Demand Draft/Banker's cheque, etc., payable at Mizoram.
2. The Tender should consist of two Bids-The Techno-Commercial Bid(Bid I) and the Financial Bid (Bid II). Both must be submitted in two separate envelopes to be sealed and put in a single main cover. The outer main cover should be superscribed "TENDER RC(MZ)CO/84/86/Pt.II dtd.04th December, 2013 (separate envelope to be used for separate work) addressed to "THE JOINT DIRECTOR, ICAR RESEARCH COMPLEX FOR NEH REGION, MIZORAM CENTRE, KOLASIB-796081". The contractor should give their complete address on the bottom left corner of the Main cover .The cost of the Tender as well as the Earnest money,& All sorts of papers/documents like ITC, PTC, Enlistment, PAN card, etc should be mandatory kept in the Technical Bid only. The financial Bid should consist of the rates, their detailed break-ups, etc. All Tenders should be sent by Registered Post. Tenders to be hand delivered should be in the office of the Joint Director , ICAR Research Complex for NEH Region , Mizoram Centre,Kolasib-796081 not later than 2.00PM on **24.12.2013**. Tender received after the due date and time shall not be considered under any circumstances.

3. The rates quoted should be up to ICAR Research Complex for NEH Region, Mizoram Centre, Kolasib for the mentioned items. The rates must be valid for at least for 6(six) months from the date of quotation.
4. An Earnest Money @2.5% of the estimated cost has to be deposited in the **Office of the Joint Director ,ICAR Mizoram Centre,Kolasib-796081** by means of **Demands draft/Banker's Cheque** payable at **SBI Kolasib**.
5. After satisfactory completion of the work, bills in triplicate may be submitted to the office for arranging payment. While submitting the bills, the Contractor shall give in writing that all the statutory & legal dues/norms have been fully complied with and in case of any default, the Contractor shall be lone and sole responsible for the same.
6. The Joint Director, ICAR Research Complex ,Mizoram Centre ,Kolasib reserves the right to reject any tender either in part or full without assigning any reason thereof.
7. Payment of Contractor's bill will be made by A/c payee DD/ Cheque either from Mizoram Centre or from our Complex's H. Qrs., Umiam, ,Meghalaya.
8. In case of any dispute ,the Joint Director, ICAR Mizoram Centre shall as the arbitrator and his decision shall be final and binding on the contractor.
9. The successful tenderer has to start the awarded work within a stipulated time to be mentioned in the 'Work order', failing which, penalty @5% (five percent) of the value of tender for delay of 15 days or fraction thereof will be imposed and will be deducted from contractor's bill or the EMD and the order will stand automatically cancelled.
10. All Contractors should mandatory sign on every page of the Tender Document and should give an undertaking that they fully and unconditionally agree to abide by all the terms and conditions, which if needed, may be modified at the discretion of the Competent Authority, in Work Order, for which confirmation from the contractor shall be taken.
11. Other terms & conditions, as may be decided by the Competent Authority from time to time, depending upon the condition & requirement of the supply/work. The intimation in this regard, shall be provided well in advance & the bidder/ supplier shall be bound by the said terms & conditions.
