TERMS & CONDITIONS OF THE TENDER

- 1. The consolidate Cost of Tender paper of Rs.500/-(Rupees five hundred) only (Non-refundable) to be deposited in the favour of the Joint Director, ICAR Research Complex for NEH Region, A.P Center, Basar-791101 by means of Demand Draft payable at SBI, ICAR Complex, Basar. Non submission of the cost of Tender paper (consolidated) shall lead to non-consideration of the Tender.
- 2. The Bidders should submit the proposals in two parts/
 - a. Technical Bid (Bid-I)
 - b. Financial Bid (Bid-II)
- 3. Technical part should contain all such details as mentioned in the Bid Documents.
- 4. Financial part (BID-II) should contain the financial bid inclusive of all admissible taxes, duties and levies, installation charges, freight charges, Taxes, VAT, GST etc., as may be applicable etc.
